## Management Discussion of Fund Performance

June 3, 2019

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended March 31, 2019, that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

### Investment Objective and Strategies

The Fund seeks long-term capital appreciation by investing substantially all its assets in Mackenzie Private Canadian Focused Equity Pool (the "Underlying Fund"), which invests mainly in Canadian equities. The Underlying Fund utilizes multiple portfolio management teams with a mix of investing styles. It may hold up to 49% of its assets in foreign investments. The Underlying Fund diversifies in terms of geographic exposure, sector exposure, company market capitalization and portfolio manager style.

### Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium- to long-term investors looking for a Canadian equity fund to hold as part of their portfolio, who can handle the volatility of stock markets and who have a medium tolerance for risk. The Fund may not be held within a registered plan.

### Results of Operations

#### Investment Performance

The performance of the Fund's Series PW and Series LW securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the year, the Fund's Series PW securities returned 3.7% (after deducting fees and expenses paid by the series). This compares with a return of 9.0% for a blended index composed of a 60% weighting in the Fund's broad-based index, the S&P/TSX Composite Index (returned 8.1%), a 30% weighting in the S&P 500 Index (returned 13.6%) and a 10% weighting in the MSCI EAFE (Net) Index (returned 0.0%). Since inception

on December 7, 2018, the Fund's Series LW securities returned 8.9%, which compares with the blended index return of 9.4% for the same period. The S&P/TSX Composite Index returned 10.0%, the S&P 500 Index returned 8.7% and the MSCI EAFE (Net) Index returned 7.5% in the period since the inception of Series LW. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Despite volatility, Canadian equity markets ended the year higher as North American trade tensions abated. Oil prices stabilized after the Organization of the Petroleum Exporting Countries ("OPEC") announced a cut to production targets. Uncertainty regarding future policy rate increases by the Bank of Canada, which raised rates in July and October, weighed on markets, but central bank policy moderated as economic growth slowed. The expectation of more gradual rate increases supported equity valuations.

Within the S&P/TSX Composite Index, health care, information technology and consumer staples were the strongest sectors, while consumer discretionary, materials and financials were the weakest.

Global economic data weakened throughout the second half of the year. Europe struggled with weakening economic data and continued political challenges affecting the European Union, including negotiations over the withdrawal of the United Kingdom. Chinese equities declined due to trade disputes and a slowing economy. Emerging markets were weighed down by higher U.S. interest rates and a strengthening U.S. dollar. After some volatility, global markets recovered strongly starting in January.

Within the S&P 500 Index, real estate, utilities and information technology were the strongest sectors in Canadian dollar terms, while financials, materials and energy were the weakest.

Within the MSCI EAFE (Net) Index, New Zealand, Israel and Hong Kong were the strongest performers in Canadian dollar terms, while Austria, Belgium and Germany were the weakest. From a sector perspective, utilities, health care and energy were the strongest performers, while financials, consumer discretionary and communication services were the weakest.

The Underlying Fund currently invests all its assets in other funds managed by Mackenzie, and the following discussion reflects the activities of these underlying funds. The Fund underperformed both the broad-based index and the blended index, with stock selection in Canada detracting from performance relative to both indices. Conversely, exposure to the United States contributed to performance relative to the broad-based index. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

Relative to the blended index, an underweight position and stock selection in the information technology sector detracted from performance, as did stock selection in the consumer discretionary and real estate sectors. In geographic terms, exposure to South Korea, China and Taiwan detracted. Conversely, stock selection in the financials sector and in the United States contributed to performance.

The Fund hedged its foreign currency exposure at times in the year, which contributed to performance even as the U.S. dollar appreciated relative to the Canadian dollar.

The portfolio management team made substantial changes to the Fund's portfolio over the year. Most notably, new allocations to Mackenzie Maximum Diversification Canada Index ETF, Mackenzie Canadian Growth Fund, Mackenzie Global Small Cap Fund, Mackenzie Maximum Diversification All World Developed ex North America Index ETF and Mackenzie US Mid Cap Growth Class were added, and the allocation to Mackenzie US Low Volatility Fund was eliminated.

These changes, along with portfolio activity and market effect, resulted in increased exposure to China, the Netherlands and Taiwan, and reduced exposure to Australia. At the sector level, exposure to communication services, health care and materials increased, while exposure to financials and energy decreased.

Effective October 1, 2018, the definition of equity sectors under the Global Industry Classification Standards changed. The new communication services sector encompasses the previous telecommunication services sector and the media industry, which was previously included in consumer discretionary. Communication services also includes internet companies that were previously in the information technology sector. Internet retailers and e-commerce companies were reclassified from information technology to consumer discretionary.

## Net Assets

The Fund's NAV increased by 28.2% to \$5.5 million at March 31, 2019, from \$4.3 million at March 31, 2018. This change was composed primarily of \$0.2 million in net income (including dividend and interest income) from investment performance, after deducting fees and expenses, and \$1.1 million in net sales.

At March 31, 2019, 24.5% of the Fund's NAV was held by investors that individually owned 10% or more of the Fund. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At March 31, 2019, Mackenzie had received no such notices.

## Fees and Expenses

The management expense ratio ("MER") for Series PW of 2.13% during the year ended March 31, 2019, was lower than the MER of 2.24% for the year ended March 31, 2018. The annualized MER for Series LW was 2.09% since inception. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report. The MERs for certain series decreased due to a decrease in the management fee rates effective June 1, 2018, as noted in the *Fund Formation and Series Information* section of the report. The MERs for Series PW, Series PWF5, Series PWF8, Series PWFB, Series PWFB5 and Series PWT8 also decreased due to a decrease in fund costs.

## Recent Developments

The strong market performance of most asset classes in the final quarter of the year occurred despite a notable slowdown in the global economy. The Mackenzie Multi-Asset Strategy team believes the U.S. Federal Reserve's shift to a more cautious approach in raising interest rates was an important positive factor. Meanwhile, China implemented selective targeted stimulus measures, which bolstered Chinese markets.

However, political risks remain as U.S.–China negotiations continue and the 2020 U.S. presidential campaign begins. The team also believes several U.S. economic indicators have begun to point to a slower pace of expansion. The Canadian equity market is facing challenges from slowing global economic growth and declining estimates of company earnings over the upcoming period. Europe remains weak and was exhibiting recessionary conditions at year-end. The rebound in stock valuations leaves less room for further improvements should corporate earnings disappoint investor expectations. Finally, if the soft patch in growth continues, markets may need to lower growth expectations.

On May 17, 2018, Mackenzie Investments Corporation, a subsidiary of Mackenzie, replaced JP Morgan Asset Management (Canada) Inc. as the sub-advisor to underlying fund Mackenzie Emerging Markets Class. The Mackenzie Global Quantitative Equity team, led by Arup Datta, now manages this underlying fund using a quantitative investment approach, with a focus on mid- and small-cap stocks.

## Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

## Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

## Other Related Party Transactions

At March 31, 2019, Mackenzie had an investment of \$12,317 in the Fund (0.2% of the Fund's NAV).

The Fund did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions.

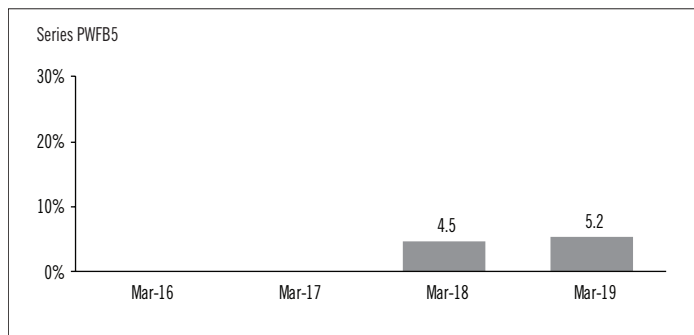
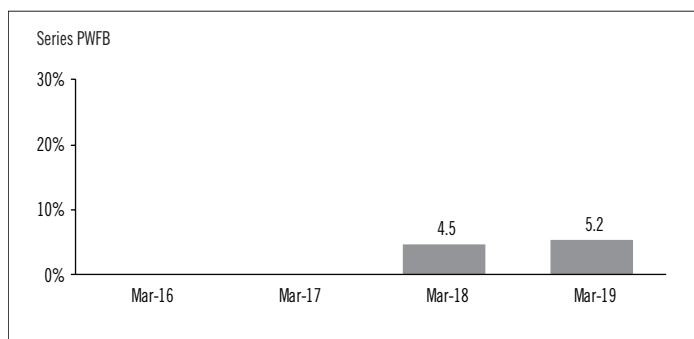
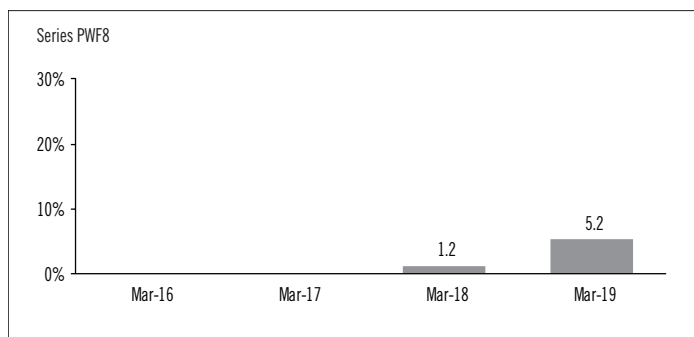
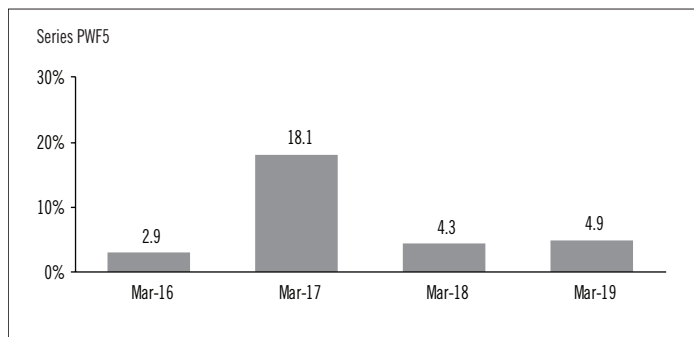
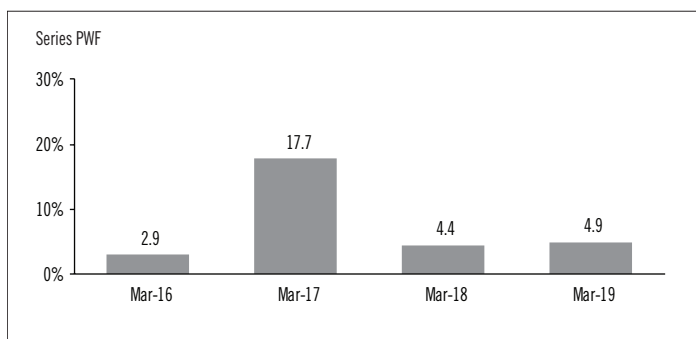
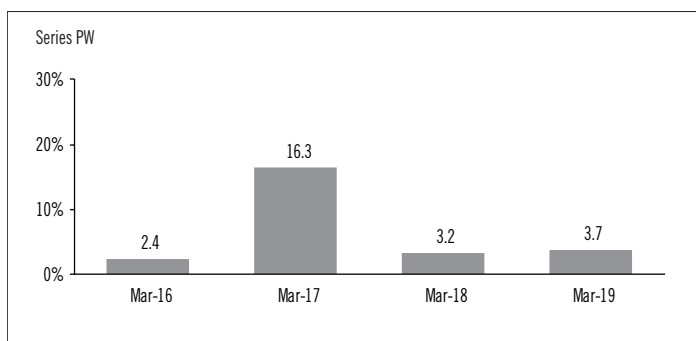
## Past Performance

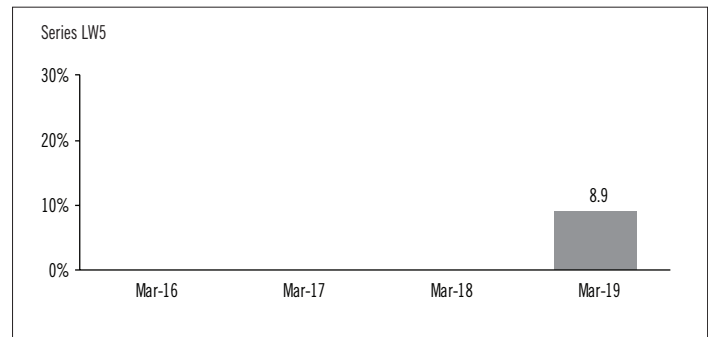

The S&P 500 Index is a market capitalization weighted index of 500 widely held securities, designed to measure broad U.S. equity performance.

The MSCI EAFE (Europe, Australasia, Far East) (Net) Index is a free float adjusted, market capitalization weighted index that is designed to measure the equity market performance of developed markets, excluding the United States and Canada. It consists of 21 developed market country indices. Net total returns are after the deduction of withholding tax from the foreign income and dividends of its constituents.

## Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under *Fund Formation and Series Information*) and receives a portion of the management fees that the Fund pays to Mackenzie. Under this arrangement, LBC was entitled to approximately 23% of the total management fees that Mackenzie received from the LBC series of all Mackenzie funds during the year. Mackenzie is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

Mackenzie used approximately 43% of the total management fee revenues received from all Mackenzie funds during the year to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 38% of the management fees paid by all applicable series of the Fund during the year. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Investors in Series PWF5 and Series PWF8 securities also want to receive a monthly cash flow of 5% or 8% per year, respectively.
