## Management Discussion of Fund Performance

June 3, 2019

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended March 31, 2019, that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

### Investment Objective and Strategies

The Fund seeks income with some long-term capital growth by investing primarily in fixed income and income-oriented equities of issuers anywhere in the world, either directly or through other mutual funds. The Fund utilizes multiple portfolio management teams with a mix of investing styles. The Fund's asset mix will generally range between 20%–40% equities and 60%–80% fixed income securities. The Fund diversifies in terms of geographic exposure, sector exposure, company market capitalization, portfolio manager style, credit quality and duration.

### Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium-term investors looking for a global income-oriented balanced fund to hold as part of their portfolio, who can handle the volatility of stock and bond markets, and who have a low tolerance for risk.

### Results of Operations

#### Investment Performance

The performance of the Fund's Series PW and Series LW securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the year, the Fund's Series PW securities returned 3.1% (after deducting fees and expenses paid by the series). This compares with a return of 5.4% for a blended index composed of a 70% weighting in the Fund's broad-based index, the ICE BofAML Global Broad Market (Hedged) Index (returned 4.1%), and a 30% weighting in the MSCI World (Net) Index (returned 8.0%). Since inception on December 7, 2018, the Fund's Series LW securities returned 5.1%, which compares with the blended index return of 5.1% for the same period. The ICE BofAML Global Broad Market (Hedged) Index returned 3.6% and the MSCI World (Net) Index returned

8.3% in the period since the inception of Series LW. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Performance varied across developed global sovereign bond markets. In general, yields on longer-term bonds declined and yield curves flattened as central banks took a more pessimistic view of growth as the year progressed. Emerging markets stabilized in January after the U.S. Federal Reserve shifted away from monetary tightening, introducing some uncertainty about the strength of the U.S. dollar. Despite volatility, the Canadian dollar was relatively strong, benefiting from a solid economic backdrop.

Global economic data weakened throughout the second half of the year. Europe struggled with weakening economic data and continued political challenges affecting the European Union, including negotiations over the withdrawal of the United Kingdom. Chinese equities declined due to trade disputes and a slowing economy. Emerging markets were weighed down by higher U.S. interest rates and a strengthening U.S. dollar. After some volatility, global markets recovered strongly starting in January.

Within the MSCI World (Net) Index, New Zealand, Israel and the United States were the strongest performers in Canadian dollar terms, while Austria, Belgium and Germany were the weakest. From a sector perspective, information technology, utilities and real estate were the strongest performers, while financials, materials and industrials were the weakest.

The following discussion reflects the activities and performance of the Fund's underlying mutual funds and other directly held securities. The Fund underperformed both the broad-based index and the blended index, with its cash position detracting from performance as fixed income and equity markets rose. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

Within the fixed income portion of the Fund, having a shorter duration than the broad-based index detracted from performance. Conversely, yield curve positioning within municipal bonds contributed to performance.

Within the equity portion of the Fund, stock selection in the health care, consumer staples and utilities sectors detracted from performance. At the country level, stock selection in Canada and the United States detracted. Conversely, stock selection in the financials, information technology and materials sectors contributed to performance, as did stock selection in France and the United Kingdom.

The Fund partially hedged its exposure to selected foreign currencies, which detracted from performance primarily as the U.S. dollar appreciated relative to the Canadian dollar.

The portfolio management team made substantial changes to the Fund's portfolio over the year. Most notably, new allocations to Mackenzie Global Credit Opportunities Fund, Mackenzie Strategic Bond Fund, Mackenzie Canadian Growth Fund and Mackenzie Multi-Strategy Absolute Return Fund were added. In addition, the Fund began investing in various bond- and equity-based exchange-traded funds to provide investors with access to asset classes that are less represented in typical portfolios, with the aim of improving the risk-return characteristics of the Fund.

These changes, along with portfolio activity and market effect, resulted in increased exposure to equities and reduced exposure to fixed income. Exposure to Mexico was introduced, exposure to Canada increased and exposure to the United Kingdom, Poland and China decreased. Within the fixed income portion of the Fund, exposure to federal bonds, provincial bonds and term loans increased, while exposure to foreign government bonds, corporate bonds and supra-national bonds decreased. The portfolio management team continually makes tactical adjustments to the Fund's fixed income allocations, so these year-end exposures do not necessarily represent a long-term strategic position. Within the equity portion of the Fund, exposure to the information technology sector decreased.

Effective October 1, 2018, the definition of equity sectors under the Global Industry Classification Standards changed. The new communication services sector encompasses the previous telecommunication services sector and the media industry, which was previously included in consumer discretionary. Communication services also includes internet companies that were previously in the information technology sector. Internet retailers and e-commerce companies were reclassified from information technology to consumer discretionary.

## Net Assets

The Fund's NAV increased by 3.4% to \$17.9 million at March 31, 2019, from \$17.3 million at March 31, 2018. This change was composed primarily of \$0.6 million in net income (including dividend and interest income) from investment performance, after deducting fees and expenses, and \$0.1 million in cash distributions.

## Fees and Expenses

The management expense ratio ("MER") for Series PW of 1.59% during the year ended March 31, 2019, was slightly lower than the MER of 1.63% for the year ended March 31, 2018. The annualized MER for Series LW was 1.69% since inception. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report. The MERs for Series PWF and Series PWFB decreased due to a decrease in fund costs and a decrease in the management fee rates effective June 1, 2018, as noted in the *Fund Formation and Series Information* section of the report.

## Recent Developments

The strong market performance of most asset classes in the final quarter of the year occurred despite a notable slowdown in the global economy. The Mackenzie Multi-Asset Strategy team believes several U.S. economic indicators have begun to point to a slower pace of expansion, although the team does not anticipate a recession in 2019. Europe remains weak and was exhibiting recessionary conditions at year-end. The rebound in stock valuations leaves less room for further improvements should corporate earnings disappoint investor expectations.

Unless U.S. domestic growth and markets rise significantly, the team believes the U.S. Federal Reserve is unlikely to raise rates in 2019. The team believes the European Central Bank and the Bank of Japan will keep monetary conditions accommodative as confidence in their respective economies falters. The team expects the Bank of Canada to continue relying on Canadian economic data but also to consider U.S. monetary policy and interest rate decisions.

To align with new securities regulations, Mackenzie updated the investment objective and strategies of underlying fund Mackenzie Multi-Strategy Absolute Return Fund effective January 11, 2019. These changes provide additional flexibility for using derivatives, short selling and borrowing.

## Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

## Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

## Other Related Party Transactions

At March 31, 2019, Mackenzie had an investment of \$8,504 in the Fund (less than 0.1% of the Fund's NAV).

The Fund did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions.

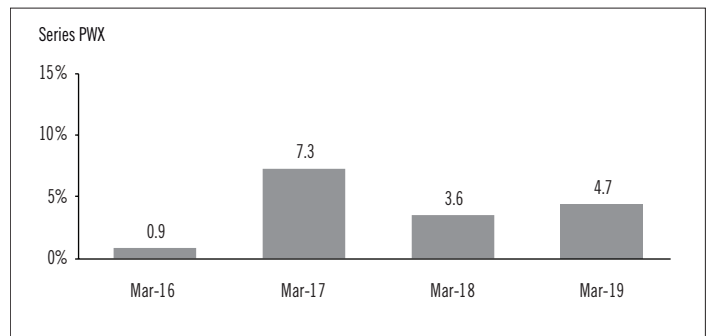
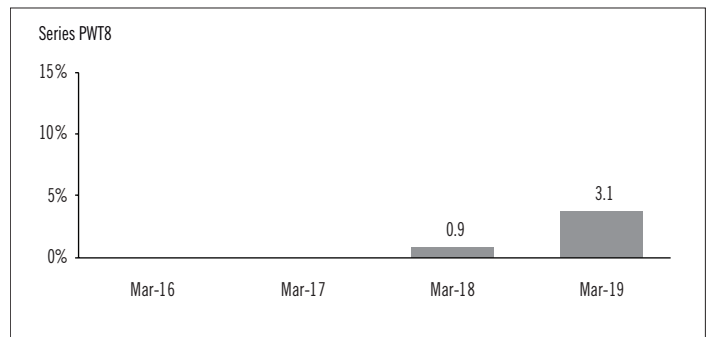
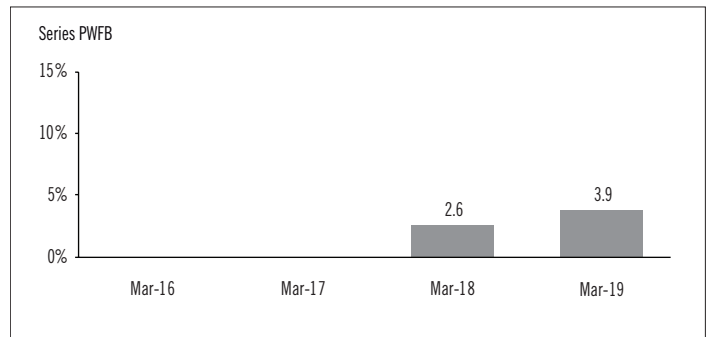
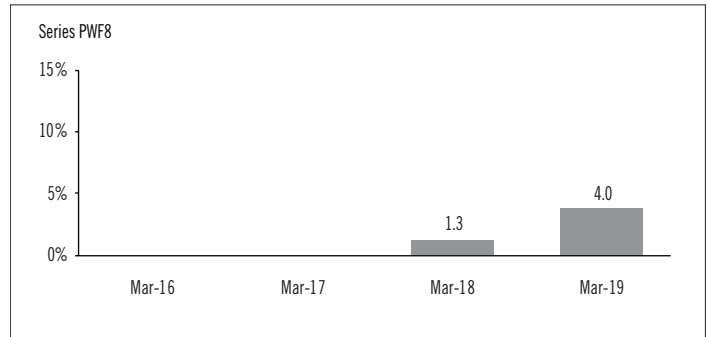
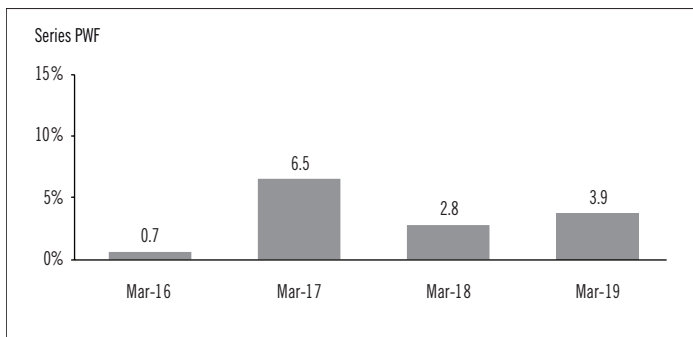
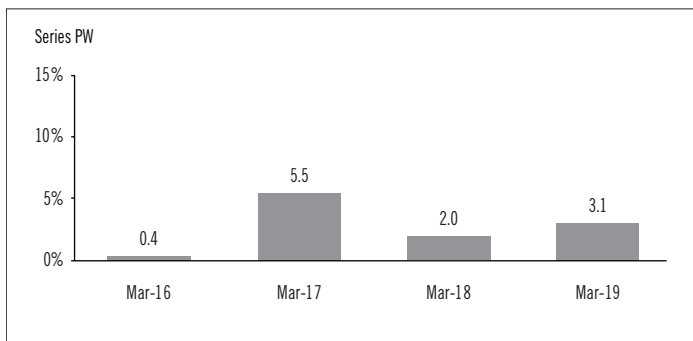
## Past Performance

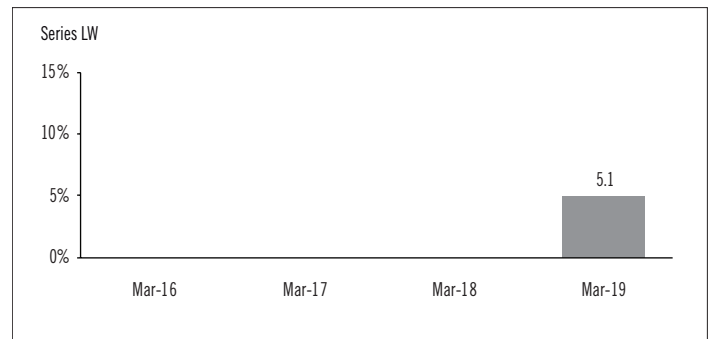
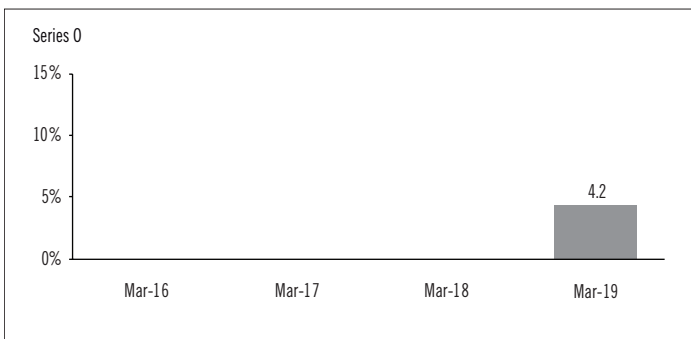
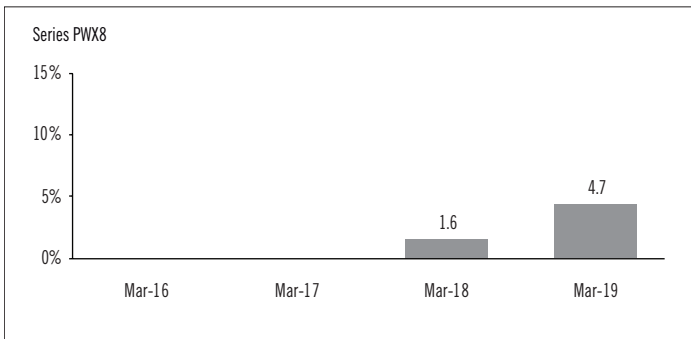

### \* Broad-based index

The blended index is composed of 70% ICE BofAML Global Broad Market (Hedged) Index and 30% MSCI World (Net) Index.

The ICE BofAML Global Broad Market (Hedged) Index tracks the performance of investment grade debt publicly issued in the major domestic and eurobond markets, including sovereign, quasi-government, corporate, securitized and collateralized securities. Qualifying bonds must be rated "BBB" or higher and have a remaining term to maturity of at least one year. The foreign currency exposure is hedged back to the Canadian dollar.

The MSCI World (Net) Index is a free float adjusted, market capitalization weighted index that is designed to measure the equity market performance of developed markets. It consists of 23 developed market country indices. Net total returns are after the deduction of withholding tax from the foreign income and dividends of its constituents.

## Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under *Fund Formation and Series Information*) and receives a portion of the management fees that the Fund pays to Mackenzie. Under this arrangement, LBC was entitled to approximately 23% of the total management fees that Mackenzie received from the LBC series of all Mackenzie funds during the year. Mackenzie is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

Mackenzie used approximately 43% of the total management fee revenues received from all Mackenzie funds during the year to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 37% of the management fees paid by all applicable series of the Fund during the year. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.
