Management Discussion of Fund Performance

November 12, 2019

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the period ended September 30, 2019, that have affected the Fund's performance and outlook. If the Fund was established during the period, "period" represents the period from inception to the end of the fiscal period. For information on the Fund's longer-term performance, as applicable, please refer to the *Past Performance* section of the report. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

The performance of the Fund's Series A securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

During the period, the Fund's Series A securities returned -1.5% (after deducting fees and expenses paid by the series). This compares with the MSCI EAFE (Net) Index return of 1.6%. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Stocks in Europe, Australasia and the Far East ("EAFE") generally posted healthy gains in local currency terms over the period, while Canadian dollar returns were slightly lower due to the strength of the dollar. The United Kingdom was one of the weaker-performing countries in Europe as concerns over its potential withdrawal from the European Union continued to weigh on the market. Hong Kong experienced protests and political unrest, leaving little room for the optimism required to lift equity markets.

Within the MSCI EAFE (Net) Index, Switzerland, the Netherlands and Australia were the strongest-performing countries in Canadian dollar terms, while Hong Kong, Israel and Austria were the weakest. From a sector perspective, consumer discretionary, information technology and health care were the strongest performers, while energy, real estate and materials were the weakest.

The Fund invested all its assets in Mackenzie Maximum Diversification All World Developed ex North America Index ETF (the "Underlying ETF"), which tracks the TOBAM Maximum Diversification All World Developed ex North America Index. The Underlying ETF's core investment philosophy is to seek enhanced diversification through a balanced exposure to all relevant risk factors in the non-North American developed country equity markets. As a result of this approach, the Fund may have less concentrated risk exposures than those of a market capitalization weighted index, such as the MSCI EAFE (Net) Index.

The Fund underperformed the MSCI EAFE (Net) Index, with the Underlying ETF's overweight exposure to Hong Kong and stock selection in Japan detracting from performance. In sector terms, stock selection in health care and consumer staples detracted.

Conversely, stock selection in Australia, Germany and France contributed to performance. In sector terms, stock selection in materials and communication services contributed.

The Fund's foreign currency exposure was not hedged. Currency exposure detracted from the performance of both the Fund and the index primarily as the euro and the British pound depreciated relative to the Canadian dollar.

Over the period, changes were made to the Underlying ETF's holdings to reflect changes in the composition of the TOBAM Maximum Diversification All World Developed ex North America Index. Exposure to New Zealand increased, while exposure to Spain and Hong Kong decreased. At the sector level, exposure to consumer staples and communication services increased, while exposure to information technology decreased.

Net Assets

The Fund's NAV declined by 8.2% to \$23.8 million at September 30, 2019, from \$25.9 million at March 31, 2019. This change was composed primarily of \$0.3 million in net losses (after including dividend income) from investment performance, after deducting fees and expenses, and \$1.9 million in net redemptions.

Fees and Expenses

The annualized management expense ratio ("MER") for Series A of 1.99% during the period ended September 30, 2019, was slightly lower than the MER of 2.02% for the year ended March 31, 2019. The MERs (before and after waivers or absorptions, if any) for all series are presented in the *Financial Highlights* section of this report. The MER for Series T5 decreased due to a decrease in fund costs and a decrease in the management fee rate effective August 2, 2019, as noted in the *Fund Formation and Series Information* section of the report.

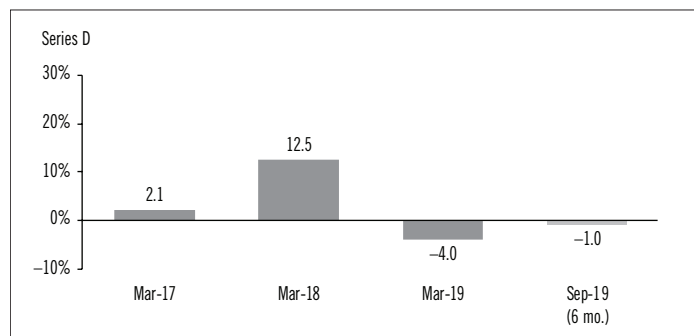
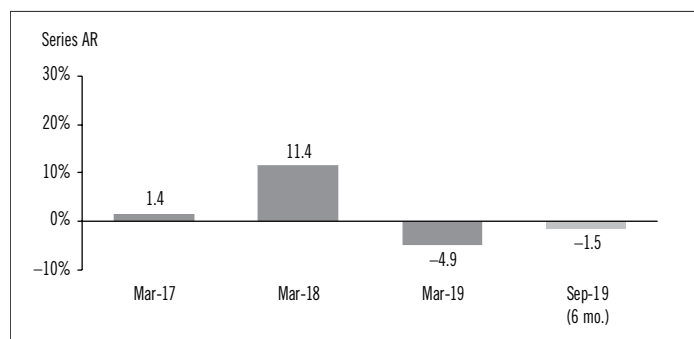
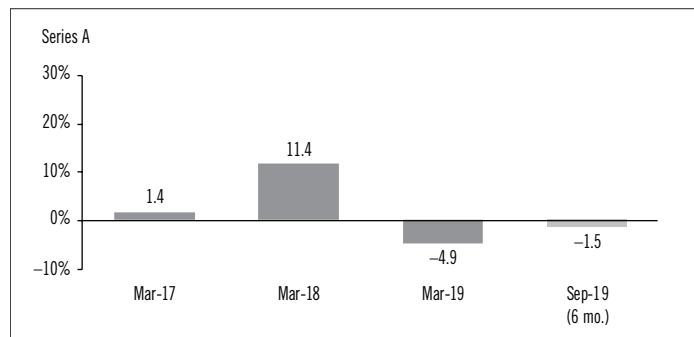
Other Related Party Transactions

The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

Mackenzie used approximately 43% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 40% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series PWF and Series PWF5 securities are no longer available for sale. Effective June 1, 2018, Series PWF and Series PWF5 securities were consolidated into Series F and Series F5 securities, respectively.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option and a low-load purchase option. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to Mackenzie if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series.
